Homeland Security Resources for the Public

Active Shooter Preparedness – Following the tragic attacks in San Bernardino and Paris in late 2015, the Office of Homeland Security and Preparedness, the Regional Operations Intelligence Center, and the State Police developed an Active Shooter Response Training to provide the public with guidance on how to prepare for and respond to an active shooter situation. These nationally recognized procedures may be applied to all businesses, government offices, and large public gathering areas.

Facility Self-Assistance Tool – This document was designed to aid in conducting a facility security review. Completing the questionnaire honestly and accurately will quickly direct you to potential areas of security concern, which may be used at workplaces, religious facilities and houses of worship. Once an area of security concern has been identified, we encourage you to contact your local police, first responders and fire to address and explore all options available.

Faith-Based Security Strategy – The Interfaith Advisory Council facilitates the faith-based security strategy for New Jersey's houses of worship, which has been shared with law enforcement and faith-based communities throughout the State. This strategy includes security guidelines for houses of worship, outlines the development of security coordinators, and promotes awareness and resources provided by local, state, and federal agencies.

Terrorism Threat Assessment – Our intelligence analysts are assigned specific portfolios on international and domestic terrorist groups and critical infrastructure sectors. Each analyst serves as the subject-matter expert on their portfolio, which drives the production of tailored analysis for our partners. We disseminate this analysis through written products, graphics, webinars, and briefings.
